## What is Public Authority?

The Public Authority manages a Registry to help and serve consumers in San Benito County. The Public Authority Registry will assist eligible consumers to help find potential providers who are willing to work and provide essential care for IHSS consumers.

The Public Authority Registry is a referral and voluntary service. A process which IHSS consumers are in need of assistance and registry providers are in need of employment can be “matched” in attempt to deliver In-Home Supportive Services.

The Public Authority is also responsible for all IHSS providers to have all required documents and the provider enrollment process completed.

## WHAT IS IHSS?

In-Home Supportive Services (IHSS) program provides services to qualified aged, blind, and/or disabled individuals. The goal of this program is to allow people to remain safely in their own homes and avoid the need for out of home care. IHSS is a county-administered and Medi-Cal based program who pays a family member or a homecare registry to assist individuals for IHSS authorized services.

An IHSS Social Worker will set up an appointment to meet with you at your home and will assess the types of services you may need and how often you will need services in good and bad days. During your home visit the IHSS Social Worker will talk with you about any medical conditions, living arrangements and any help you might be getting from your family, friends or others.

### *Need help finding a Registry Provider?*

Public Authority staff can assist you with finding an Individual Provider (IP) by generating a customized list of providers who can best fulfill the consumer’s needs, preferences & availability.

The consumer is the *employer*. Once you choose a new provider you are responsible to hire, train and supervise the provider. Also, the consumer has the right to terminate the provider, if the provider does not follow through and does not comply with the IHSS rules and regulations.

A potential Registry Provider (IP) has successfully completed the following steps:

- a. Completed a Registry Provider Application
- b. Submitted and Passed References
- c. Attended an Orientation
- d. Submitted fingerprints, undergo and Passed a Criminal Background Check by the DOJ
