San Benito County supervisors Jim Gillio and Peter Hernandez are scheduled to host a virtual town hall Friday with Senator Anna Caballero and Assembly member Robert Rivas. They are addressing business concerns derived from the San Benito County Chamber's COVID-19 survey and the County's economic impact surveys.

In partnership with the San Benito Chamber of Commerce, San Benito Business Council, Economic Development Corporation, Hollister Downtown Association, Cal Coastal SBDC, and the City of Hollister, City of San Juan Bautista, and San Benito County agency leaders. The meeting is set to include updates around the County's, Health Order, discussion of essential business, social distancing protocols, mask-covering overview, resources available to local organizations, price gouging, enforcement of shelter in place, construction industry guidelines, plans for economic recovery, webinars, training, tools, and workforce retention and reemployment.
