COVID-19 UPDATE: OCTOBER 16, 2020

This report is based on only available data; not all results have been received.





San Benito County (SBC) Public Health Services continues to work with medical providers to identify and test individuals who meet criteria for COVID-19 testing. As of October 16, 2020, four new cases have been reported, for a total of 1,396 confirmed cases of COVID-19 in SBC. Confirmed cases include patients who have since recovered and those who are deceased. Fifty-three percent (734) of positive cases reported were female; ages ranged from 2 months to 101 years (median: 36 years).







Person-to-person transmission occurs when infection is spread through a confirmed contact. Person-to-person transmission typically occurs in close-contact environments, such as households or workplaces.









GOAL: Less than 4 daily new cases (per 100k) for 2 consecutive weeks.

California Blueprint for a Safer Economy

TIER 1: WIDESPREAD

- More than 7 daily new cases (per 100k).
- More than 8% positive tests.

TIER 2: SUBSTANTIAL

- 4-7 daily new cases (per 100k).
- 5-8% positive tests.

TIER 3: MODERATE

- 1-3.9 daily new cases (per 100k).
- 2-4.9% positive tests.

TIER 4: MINIMAL

- Less than 1 daily new cases (per 100k).
- Less than 2% positive tests.
