# **HELPFUL HINTS**

- CHECK IN REGULARLY WITH STUDENTS
   AND/OR CAREGIVERS.
- PROVIDE ENCOURAGING MESSAGES.
- ASK QUESTIONS TO ENGAGE
   CHILDREN. EX: "GIVE ME ONE WORD
- THAT DESCRIBES HOW YOU FEEL TODAY?"
- MAKE AN EFFORT WITH CHILDREN
   WHO MAY HAVE A HISTORY OF
   TRAUMA OR STRESS IN THEIR LIVES.





# WHERE TO REPORT



SAN BENITO COUNTY HEALTH & HUMAN SERVICES CHILD PROTECTIVE SERVICES AT 831-636-4190

IF YOU REASONABLY SUSPECT A CHILD IS UNSAFE – REPORT. YOU DO NOT NEED PROOF. YOU ARE NOT INVESTIGATING THE FAMILY. YOU ARE ASKING FOR A PROFESSIONAL TO HELP A CHILD AND THEIR FAMILY.

WHEN YOU MAKE A REPORT IN GOOD FAITH YOU ARE PROTECTED AGAINST CIVIL/CRIMINAL PENALTY OR ADVERSE EMPLOYMENT ACTION.

# SIGNS OF CONCERN

- A child communicates they feel unsafe, you notice a significant change in the child's mood/behavior/or appearance, or you see the child in an unsafe environment.
- Lack of a virtual attendance or homework not completed over long period of times.
- If you have no contact at all with a family after repeated phone calls/messages.
