Improper disposal of medication and sharps poses serious health and safety threats. Use this guide for free safe and proper disposal of your used sharps and unused or expired medication.

Mail-Back Envelopes

Free and available at **all local pharmacies** and at **San Benito County Public Health Services** located at:

- 351 Tres Pinos Road, A-202 Hollister, CA 9502
- Monday - Friday 8 am - 5 pm



Fill the envelope with *unused, unwanted, or expired medications*, seal the envelope, and drop off at your local USPS mailbox. Shipping costs are included.
