

San Benito County Health Officer Orders Specific Sectors, Businesses, Establishments, or Activities to Cease Operations in the County

San Benito County, California July 8, 2020: On July 1, 2020, in response to the accelerating number of cases in California, Governor Gavin Newsom instituted a statewide order for counties that are experiencing high daily case counts, increased test positivity, increased hospitalization, or limited hospital capacity for three or more consecutive days.

As indicated in the press release on July 7, 2020, California Department of Public Health Officials placed San Benito County on the COVID-19 County Data Monitoring Project watch list. As of July 7, 2020, San Benito County has been on the monitoring list for 3 consecutive days.

San Benito County exceeded the state's 14-day case rate threshold of 100 cases per 100,000 residents and the overall positivity rate. The County' current value is 107.8. The 14-day case rate equals the total number of cases diagnosed and reported over a 14-day period divided by the number of people living in the county. This number is then multiplied by 100,000. Further, the overall testing positivity rate for the past seven days >8%. The County's current value is 8.6%.

Beginning at 11:59 PM on Friday, July 10 the following modifications will be required:

- 1) All brewpubs, breweries, bars, and pubs, both indoor and outdoor are directed to close immediately for not less than three weeks from the date of the Health Officer order unless:
 - a. They offer sit-down outdoor meals only (either directly provided or through contract with another vendor).
 - b. Alcohol is only to be sold in the same transaction as a meal.
 - c. Venues that are currently authorized to provide off sale beer, wine, and spirits to be consumed off premises and do not offer sit-down, dine-in meals should follow the <u>guidance for retail operations (PDF)</u> and offer curbside sales only.
- 2) Restaurants, wineries, tasting rooms, family entertainment centers, movie theaters zoos and museums and cardrooms are only allowed in outdoor settings an in accordance with state <u>guidance</u>.
- 3) This order may be extended beyond three weeks depending on epidemiological conditions.

As a reminder, it is now a statewide mandate to wear a cloth face covering inside of, or in line to enter any indoor public space, or when unable to maintain six feet of social distance outside. San Benito County health officials strongly recommend all residents (including business sectors) to practice the following safety measures to reduce the spread of COVID-19:

- ✓ Wear a cloth face covering;
- ✓ Clean and disinfect frequently touched surfaces such as door handles and elevator buttons;
- ✓ Practice social distancing;
- ✓ Wash hands with soap and warm water for 20 seconds;
- ✓ When handwashing is not possible, use hand sanitizer with 60 percent alcohol base;

ORDER OF THE HEALTH OFFICER OF THE COUNTY OF SAN BENITO DIRECTING CLOSURE OF CERTAIN ACTIVITIES

EFFECTIVE DATE OF ORDER: July 10, 2020, at 11:59 p.m.

ALL BREWPUBS, BREWERIES, BARS, AND PUBS AND INDOOR OPERATIONS OF SPECIFIC INDUSTRIES UNTIL FURTHER NOTICE

On July 1, 2020, in response to the accelerating number of cases in California, Governor Gavin Newsom instituted a statewide order for counties that are experiencing high daily case counts, increased test positivity, increased hospitalization, or limited hospital capacity for three or more consecutive days.

On July 5, 6 and 7, 2020, San Benito County has recorded daily cases counts exceeding these limits and State health officials have directed San Benito County to close or modify for a period of not less than three weeks.

AS DIRECTED BY THE CALIFORNIA DEPARTMENT OF PUBLIC HEALTH (CDPH) AND UNDER THE AUTHORITY OF CALIFORNIA HEALTH AND SAFETY CODE SECTIONS 101030, 101040, 101085, AND 120175, TITLE 17 CALIFORNIA CODE OF REGULATIONS SECTION 2501, ARTICLE XI OF THE CALIFORNIA CONSTITUTION; CALIFORNIA GOVERNMENT CODE SECTIONS 8610, 8630, 8634, AND 8665, THE HEALTH OFFICER OF THE COUNTY OF SAN BENITO ("HEALTH OFFICER") ORDERS:

- All brewpubs, breweries, bars, and pubs, shall close indoor and outdoor operations until those establishments are allowed to resume operation per State guidance and local permission. - All Dine-in restaurants that provide sit-down meals shall cease indoor operations, follow the dine-in restaurant guidance and should continue to encourage takeout and delivery service whenever possible. - 4. All Movie Theaters shall cease indoor operations. The CDPH Guidance for movie theater operations can be found at: <u>https://files.covid19.ca.gov/pdf/guidance-family-entertainment.pdf</u>
- All Museums and Zoos shall cease indoor operations. The CDPH guidance for Museums, Galleries, Zoos, and Aquariums can be found at: <u>https://files.covid19.ca.gov/pdf/guidance-zoos-museums.pdf</u>
- 6. All Cardrooms shall cease indoor operations. The CDPH Guidance for Cardrooms can be found at: <u>https://files.covid19.ca.gov/pdf/guidance-cardrooms-racetracks.pdf</u>
- 7. All wineries and wine tasting rooms shall cease indoor operations and comply with the required Guidance for tasting rooms at: <u>https://files.covid19.ca.gov/pdf/guidance-restaurants-bars.pdf</u>.
- 8. Venues that are currently authorized to provide off sale beer, wine, and spirits to be consumed off premises and do not offer sit-down, dine-in meals shall follow the guidance for retail operations and offer curbside sales only, until local and/or statewide rules allow additional retail activity. - Producers of beer, wine, and spirits shall follow the CDPH guidance for manufacturing operations found at: <u>https://files.covid19.ca.gov/pdf/guidance-manufacturing.pdf</u>.
- 10. Face masks must be worn while indoors at all gyms and fitness centers. The CDPH guidance on fitness facilities can be found at: <u>https://files.covid19.ca.gov/pdf/guidance-fitness.pdf</u>
- 11. This guidance is not intended for concert, performance, or entertainment venues. Those types of establishments shall remain closed until they are allowed to resume modified or full operation through a specific reopening order or guidance. Establishments that serve full meals must discontinue this type of entertainment until these types of activities are allowed to resume modified or full operation. - 12. The sectors at issue in this document are all high risk of transmission due to a number of features of the businesses and the behaviors that occur within them. These sectors, foundationally, are settings where groups convene and may mix with others for prolonged periods of time without appropriate protective equipment, such as a face covering. For example, it is difficult to consistently wear a face covering in a restaurant. Additionally, physical movement within the establishment, duration of time spent in the establishment, and the degree of social mixing among individuals and groups outside one's household are all significant in these sectors, which substantially elevates the risk of transmission even where face coverings can be worn.

- 13. Alcohol consumption slows brain activity, reduces inhibition, and impairs judgment, factors which contribute to reduced compliance with recommended core personal protective measures, such as the mandatory use of face coverings and maintaining six feet of distance from people outside of one's own household, making outdoor operations for brewpubs, breweries, bars, and pubs challenging, further creating opportunities for virus transmission and thus need for closure. Additionally, there is a growing body of evidence tracing large COVID-19 outbreaks in both urban and rural states, to indoor and outdoor operations of bars.
- 14. In the setting of an increasing body of evidence demonstrating that transmission is decreased when activities are conducted outside, and risk for exposure is increased when mixing beyond those with whom one lives, in an effort to mitigate to potential spread of COVID-19, the state is requiring that settings where patrons gather to be served or participate in the businesses' primary activity be moved outdoors.
- 15. This Order is issued as a result of the worldwide pandemic of COVID-19 disease, also known as "novel coronavirus," which has infected over 10,000,000 individuals worldwide in 188 countries and is implicated in over 500,000 worldwide deaths, including over 270 cases and 2 deaths of San Benito County residents.
- 16. This Order is issued based on evidence of increasing transmission of COVID-19 both within the County of San Benito and worldwide, scientific evidence regarding the most effective approach to slow transmission of communicable diseases generally and COVID-19 specifically, as well as best practices as currently known and available to protect the public from the risk of spread of or exposure to COVID-19.
- 17. This Order is intended to address the strain upon the health care system from the effects of the COVID-19 virus. Similarly, this Order is intended to reduce the likelihood of exposure to COVID- 19, thereby slowing the spread of COVID-19 in communities worldwide.
- 18. This Order is issued in accordance with, and incorporates by reference, the March 4, 2020 Proclamation of a State Emergency issued by Governor Gavin Newsom; the March 6, 2020 Local Emergency Proclamation by the County Administrative Officer pursuant to Government Code Section 8630 proclaiming the existence of a Local Emergency in the County of San Benito regarding COVID-19; the March 10, 2020 Resolution of the Board of Supervisors of the County of San Benito ratifying and extending the Declaration of Local Health Emergency due to COVID-19; Governor Newsom's Executive Order N-33-20 of March 19, 2020 ordering all persons to stay at home to protect the health and well-being of all Californians and to establish consistency across the state in order to slow the spread of COVID- 19; Governor Newsom's Executive Order N-60-20 of May 4, 2020 and the State Public Health Officer's Order of May 7, 2020, CDPH Guidance Letter dated July 1, 2020, and all subsequent orders.

- 19. This Order is made in accordance with all applicable State and Federal laws, including but not limited to: Health and Safety Code sections 101030, et seq.; Health and Safety Code sections 120100, et seq.; and Title 17 of the California Code of Regulations section 2501. More specifically, Health and Safety Code section 120175.5(b) which provides that the local health officer may issue orders to other governmental entities within the local health officer's jurisdiction to take any action the local health officer deems necessary to control the spread of the communicable disease.
- Violation of this Order is subject to fine, imprisonment, or both. (Penal Code section 19; Government Code sections 8665 and 25132; Health and Safety Code section 120295; Health and Safety Code Sections 101030, et seq.; Health and Safety Code Sections 120100, et. Seq.; and Title 17 of the California Code of Regulations Section 2501.
- 21. To the extent necessary, pursuant to Government Code sections 26602 and 41601 and Health and Safety Code section 101029, the Health Officer requests that the Sheriff and Chief of Police in the County ensure compliance with and enforcement of this Order.
